- B. Comply with all OSHA and ANSI Safety Regulations and/or company safety policies when installing.

- ▲ DANGER Ensure area below installation is blocked off from personnel during installation.





Standard Square or Round Installation

- **NOTICE** Alternate mounting configurations detailed in full O&M available online.
- **STEP 1.** <u>Hang</u> Hinge Plate, align top of railing *or* 42" to floor.

STEP 2. Install Hoop.

CRITICAL End of gate tube must be installed within "HOOP ADJ. RANGE".




NOTICE Alternate mounting configurations detailed in full O&M available online.
